James & Rob:

Apologies, I have not had much time to focus on this since Rob provided the earlier draft. My only comment is that it is written to cover potential spring Chinook fisheries in early May, and I interpret that to mean fisheries directed at spring Chinook based on the inclusion of the spring Chinook objectives. For the state, I want to make sure that the intent is to cover other fisheries that are open in early May – the best example from this year is the Marine Area 13 mark-selective sport fishery, which is proposed to be open again in early May in current planning – it is a Chinook fishery in the spring, but not a Spring Chinook fishery...

Maybe it is simple as adding a sentence to the last full paragraph on the first page that says something like “Proposed fisheries may include marine area fisheries that would occur between May 1 and May 14 that are not directed at spring Chinook but do impact Puget Sound Chinook stocks during that period of time.” I stuck that in the attached version for review.

Finally, I don’t know whether March 15 makes sense for having a plan complete, but we can discuss that further.
