Tribal Partners,

Tomorrow, May 13, 2021, NOAA Fisheries will be issuing a final rule to implement fishery management measures for the 2021 ocean salmon fisheries off Washington, Oregon, and California as well as the 2022 salmon seasons that open earlier than the effective date of the 2022 ocean salmon fisheries rule. These measures were adopted by the Pacific Fishery Management Council (PFMC) at its April 2021 meeting.

These salmon fisheries extend from the U.S./Canada border to the U.S./Mexico border and this final rule establishes open periods, quotas, landing limits, and other management measures for these fisheries. In this rule, ocean salmon fisheries north of Cape Falcon, Oregon, will have higher quotas than in 2020, while salmon fisheries south of Cape Falcon will be restricted. In a biological opinion completed on April 21, 2021, we have concluded that these fisheries will not appreciably reduce survival and recovery of species listed under the ESA, including listed salmon, steelhead, and Southern Resident killer whales.
